SECTION 4: First-aid measures

Eye Contact: Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if

present and easy to do. Continue rinsing. Call a physician or poison control center immediately

Skin Contact: Take off immediately all contaminated clothing. Rinse skin with water/shower. Call a physician or

poison control center immediately. Chemical burns must be treated by a physician. Wash contaminated

clothing before reuse.

Inhalation: Remove victim to fresh air and keep at rest in a position comfortable for breathing. Oxygen or

artificial respiration if needed. Do not use mouth-to-mouth method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other

proper respiratory medical device. Call a physician or poison control center immediately.

Ingestion: Call a physician or poison control center immediately. Rinse mouth. Do not induce vomiting.

SECTION 6: Accidental release measures

Immediately evacuate personnel to safe areas. Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Wear appropriate protective equipment and clothing during clean-up. Do not breathe vapor. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them. Local authorities should be advised if significant spillages cannot be contained.

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Use an absorbent material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. Prevent product from entering drains. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or

other waters. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority.

Avoid release to the environment. Contact local authorities in case of spillage to drain/aquatic environment. Prevent further leakage or spillage if safe to do so. Do not contaminate water. Avoid discharge into drains, water courses or onto the ground.

SECTION 7: Handling and storage

Precautions for handling:

Protect material from direct sunlight. Do not get this material in contact with eyes. Do not get this material in contact with skin. Do not taste or swallow. Avoid prolonged exposure. Do not get this material on clothing. Use only outdoors or in a well-ventilated area. Wear appropriate personal protective equipment. Observe good industrial hygiene practices. When using, do not eat, drink or smoke. Wash hands thoroughly after handling. Avoid release to the environment. Do not empty into drains.

Condition for safe storage:

DO NOT CONTAMINATE WATER, FOOD OR FEED BY STORAGE OR DISPOSAL. Store in a dry place no lower in temperature than 50°F or higher than 120°F. Store in original tightly closed container. Store in a cool, dry place out of direct sunlight. Store in a well-ventilated place. Store away from incompatible materials.

Control parameters:

Use in an area with good general ventilation. When using, do not eat, drink or smoke. Always observe good personal hygiene measures, such as washing after handling the material and before eating, drinking, and/or smoking. Good general ventilation (typically 10 air changes per hour) should be used. Ventilation rates should be matched to conditions.
